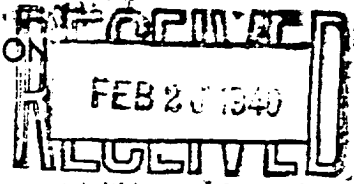

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Total depth 3724, tested thru tubing for 15 days, well made 3 BOPD with approximately 1 million cu. ft. gas. Well killed with 15 tons mud. Cement plug set at 3000'. Hole bridged at 1325' and cement plug set from that point to approximately 1285' in 8-5/8" casing. Mudded to top and marker erected.
