Reached total depth of 3680' at 10:30 a.m. CDT 9-17-84. Ran 86 joints (3678.59') of 7" OD, 23 lb/ft, ST&C casing and landed at 3679' RKB. Cemented with 600 sx of API Class-C cement containing 3% Econolite and 1/2 lb/sx Floseal followed by 250 sx of a 50-50 blend of API Class-C cement and Pozmix A containing 18% salt and 1/4 lb/sx Floseal. Plug down at 12:00 Noon 9-18-84. Circulated 318 sx of excess cement to pit. Pressure tested casing to 1500 psi and pressure held okay. Released pressure and float held okay.
