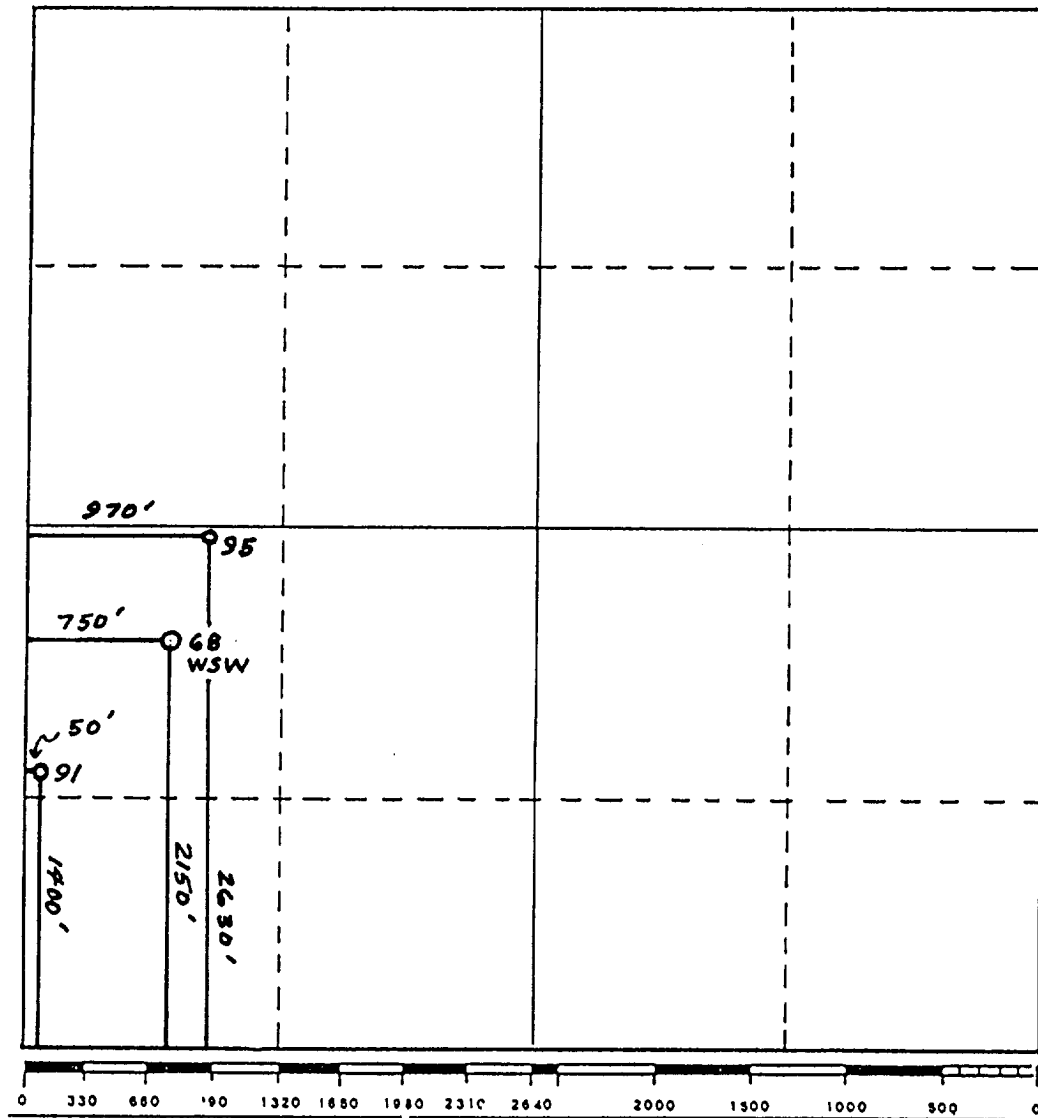

WELL LOCATION PLAT

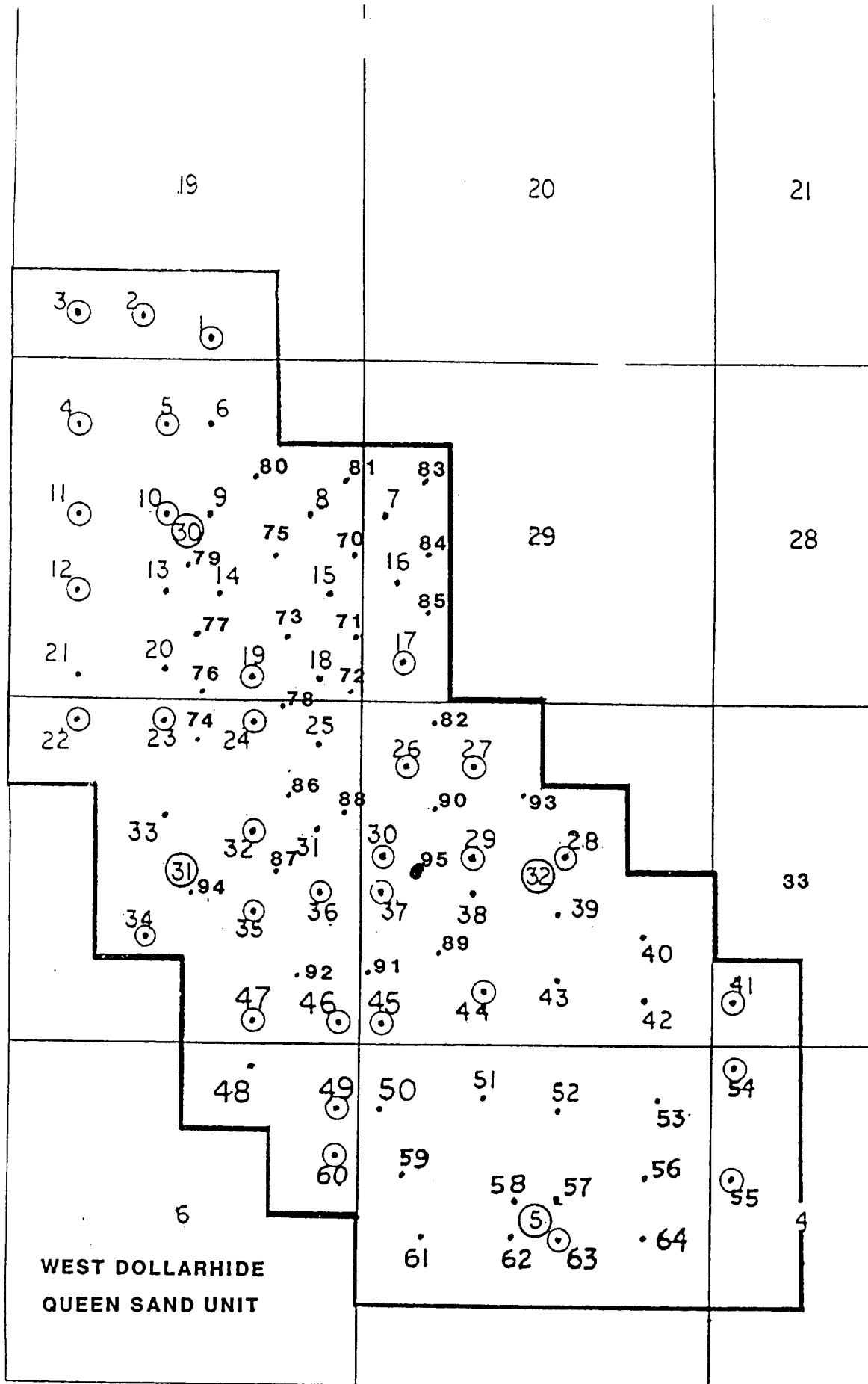
