Saga respectfully requests a renewal of the existing order maintaining the wellbore as temporarily abandoned and an extension for restoring mechanical integrity to August 1, 2001. This well has value as a producer at a later date as part of the waterflood expansion that has been proposed as a result of a geological study recently completed. The well failed its downhole mechanical integrity test even though it has a CIBP set above the perforations. Work to find and repair the source of the pressure leak-off noted on the April 2001 pressure test will be done this month. Work to return this well to an active producing status as part of the water flood expansion project is slated for sometime next year.

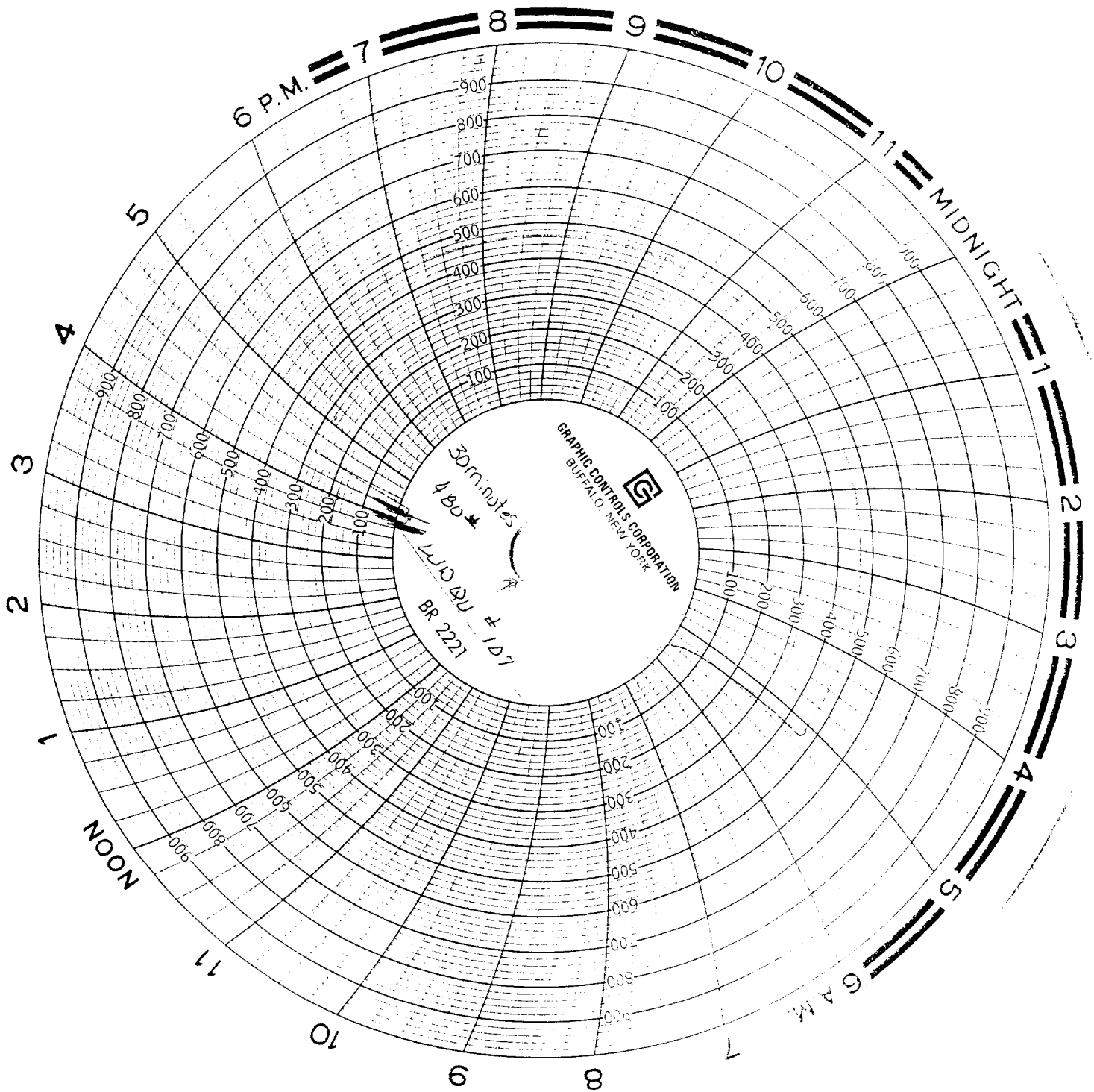
