An Exception to Rule 104 F.I. by administrative approval was granted March 14, 1990, Administrative Order NSL-2768. This well had to be moved 64' south and 85' east to clear an East-West electric line and a Northwest-Southeast pipeline. Administrative approval is requested for the new location. The revised location is 1347' FSL & 1373' FWL Unit Letter "M", of Section 32, T-24-S, R-38-E.

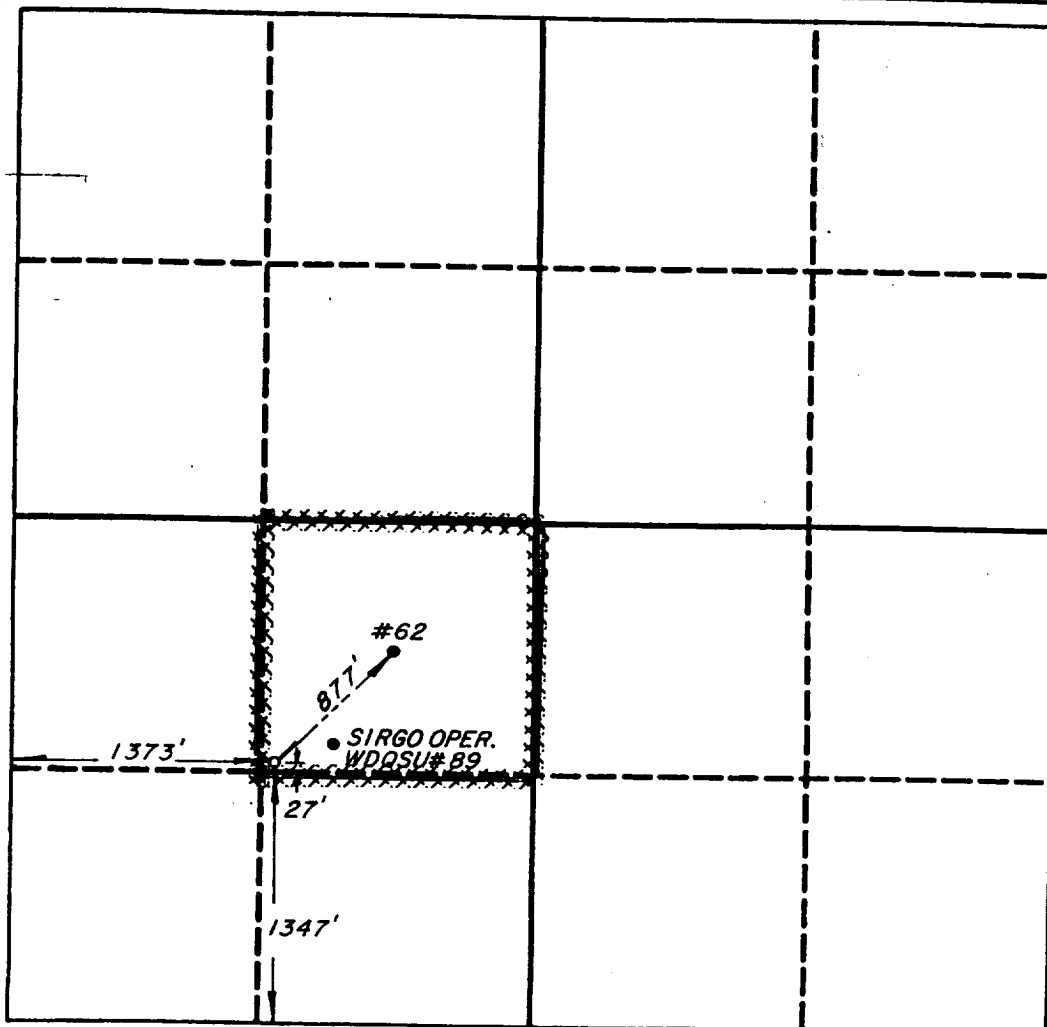

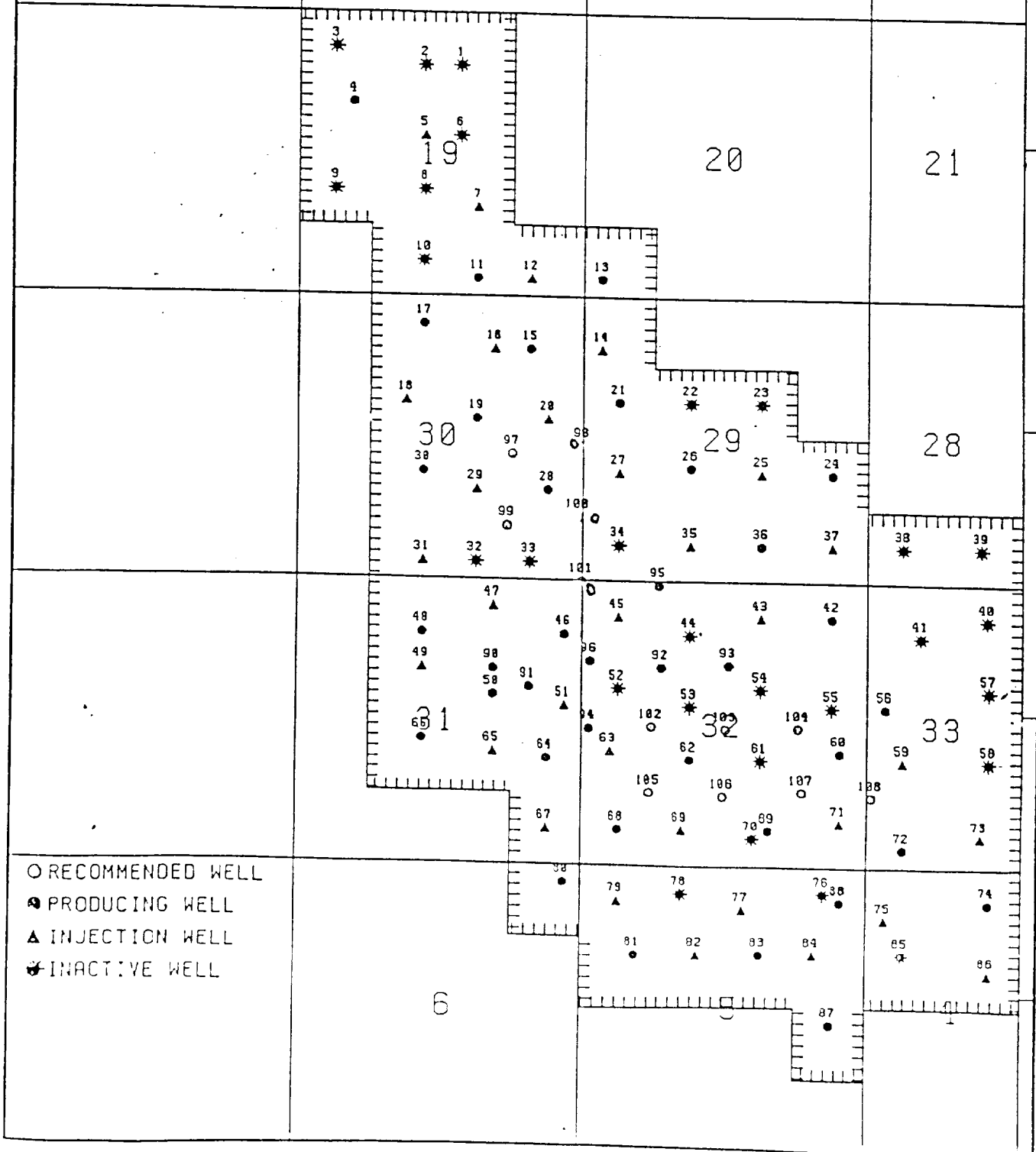
