
06/09/01 thru 06/28/01: TIH w/Guiberson G-6 packer & 2-3/8 IPC tubing - Set packer at 5054' - Pressure tested csg. - did not hold - TIH w/RBP - Set RBP at 5057' - tested to 1000# - Found holes from 4617'-4676' - ran packer down to 4900' & spot 1 sack sand - TIH w/cement retainer & set at 4546' - RU Halliburton & pump 150 sx class -C- - POOH - TIH w/packer - Found hole at 4472' - Pumped 300 sx class -C- & squeeze to 1000# - Released pkr & POOH - TIH w/bit & cleaned out to 4502' - POOH - TIH & set cement retainer at 4400' & pump 200 sx class -C- & squeeze to 1500# - Drill out cement & retainer to 4632' - pressure to 600# & lost 30#/minute - TIH w/cement retainer & set at 4450' - Pump 125 sx class -C- & squeeze to 1500# - Drilled cement retainer at 4450' & cement to 4476' - drilled 32' cement & fell out at 4508' - washed sand off RBP at 4598' - POOH with RBP - Trip in hole w/Guiberson G-6 packer & 2-3/8" IPC tubing - Set packer at 5046' - Notified NMOCD on 06/27/01 for H-5 Test - Circulated hole with packer fluid - Pressure tested 4-1/2" casing to 320# for 30" on H-5 test 06/28/01 - Held OK - Rig down and move out & put well back on injection.

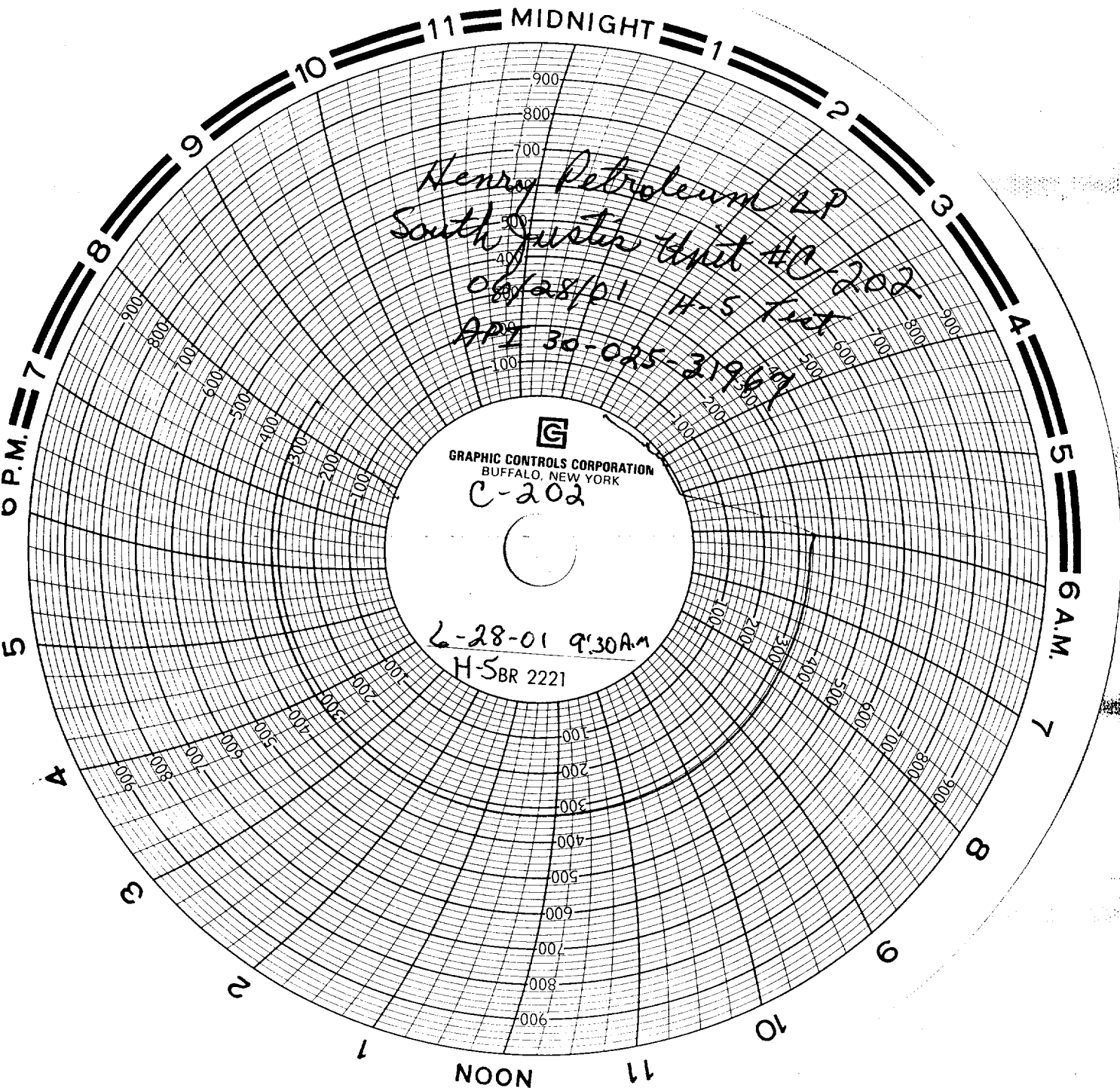
