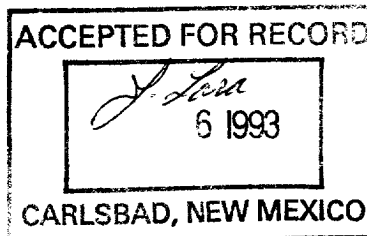

12.5 ppg, 2.03 cuft/sx (568 bbls slurry) and 200 sx C1 "C" + 2% CaCl2;  
14.8 ppg, 1.34 cuft/sx (48 bbls slurry). Circulated 193 sacks.
