THE WATERFLOOD IN THIS IMMEDIATE AREA IS BEING MONITORED FOR RESPONSE IN THE OTHER OFFSET PRODUCERS TO THE SJU "B" 12 CONVERSION. IT IS OUR INTENT TO CONVERT THE SUBJECT SJU "B" 110 FROM A WATER INJECTION WELL TO A PRODUCER WHEN OFFSET RESPONSE IS SEEN.
