9-12-97: Rigged up - SDON.


9-15-97: Hot oil rods & tubing. POOH w/rod & pump. kill well, tag for fill. TOOH. RIH w/bit & scrapper, tag @ 6147' - SDON.

9-16-97: Bled well down. POOH w/tbg laid down bit & scraper, picked up RBP & Pkr, RIH - set 6140', set Pkr @ 5725', performed chemical squeeze, unset Pkr, RIH w/tbg, unset RBF, pulled up hole w/RBP set @ 5725', set Pkr @ 5000'. Performed chemical squeeze at top zone. SDON.

9-18-97: Bled well unset packer, RIH & latched onto RBP, POOH - killed well. Laid down RBP & Pkr, RIH w/notched collar to top of perfs. SDON.


