Drl 7-7/8" hole w/native brine wtr to 3500', mud up w/SW gel to vis 35-40, MW 9.5-10 ppg & WL 10-15ccs. Log & run 5-1/2" csg, Cmt 1 stage w/600 sx Prem Plus w/gel & FLA. Circ cmt to surface, displace plug w/2% KCL FW.
