## DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 112 jts. 5 1/2" 14# and 15.5#, E. W. and Seamless, H-40 and J-55, R-2 casing. Cemented @ 3470' w/200 sax neat cement through shoe and 100 sax plus 10% gel through Baker Model "F" stage collar @ 1206'.

W.O.C. 36 hrs. Tested casing with 1200#. Held OK. Drilled out cement and plugs in stage collar at 1206'. Drilled cement to within 5' of shoe and tested casing again with 1200#. Held OK. Drilled out remaining cement and shoe. Changed drilling fluid to oil and drilled ahead by reverse circulation.
