Ran 5 $\frac{1}{2}$ " 14# & 15.5#, used and new, J-55 R-2 casing to 3472'. Cemented w/150 sack neat cement through shoe @ 3472' and 150 sack through Baker stage cement collar @ 1211'. Waited on cement 36 hours.

Tested casing w/1000# pressure 15 min; held OK. Drilled out plugs @ 1211'. Ran to bottom and tested casing w/1000#; OK. Drilled out remaining cement in casing shoe.
