Ran 113 jts. 5½" 14# E. W. casing. Cemented @ 3470 w/200 sax neat cement through shoe and 100 sax plus 9% gel through Baker Model "P" stage collar @ 1197'. WOC 36 hours. Tested casing w/800#. Held OK. Drilled out cement and plugs in stage collar @ 1197'. Drilled cement to within 5' of shoe and tested casing again w/800#. Held OK. Drilled out remaining cement and shoe. Changed drilling fluid to oil and drilled ahead by reverse circulation.
