Ran 110 jts. 5 1/2" 15.50# J-55, R-2 casing. Cemented at 3463' w/200 sax cement thro shoe and 100 sax w/10% Bentonite thro stage-collar @ 1186'.

W.O.C. 36 hours. Tested casing w/1000# - held OK. Drilled out cement and plugs in stage collar @ 1186'. Drilled cement to within 5' of shoe and tested casing again with 2000# - held OK. Drilled out remaining cement and shoe. Changed drilling fluid to oil and drilled ahead by reverse circulation.
