1. Rigged up wire line and set 2" plug in tubing on top of packer to completely isolate lower zone.
2. Pressured up to 1500# PSI. Tested OK. Swabbed dry.
3. Sleeve open above plug, plugging off Langlie Mattix zone and producing Jalmat Yates gas through 2" tubing.
