Gentlemen:

By this letter of application R. Olsen Oil Company wishes to state the following:

(a) That the R. Olsen Oil Company's Van Zandt No. 1, located in NE/4 SE/4 of Section 25, T.245, R.36E, was completed February 1, 1949, at a total depth of 3525'. The attached Exhibit "A" shows the location of this well on the R. Olsen Oil Company Van Zandt lease together with the location of offset wells.

(b) The subject well has 7" casing set at 3315' and cemented with 300 sacks of cement. A Lane Wells bridge plug is set in the 7" casing at 3300' sealing off the open hole. The well is a gas well producing through perforations 2920' to 2950' and 2960' to 3920' opposite the Yates gas sone.

(c) That the applicant proposes to dually complete the well in the following manner:

- Drill cut the bridge plug at approximately 3300' set in the 7" casing.
- (2) Set production type packer at approximately 3150' to separate the two pay sones.
- (3) Produce the Queen sil through the tubing and the Yates gas through the tubing-casing annulus.

(d) That the granting of this application for permission to produce the well as a dual completion with gas from the Yates and oil from the Queen is in the interest of conservation and the protection of correlative rights.

(e) That the applicant will comply with all rules and regulations of New Mexico Oil Conservation Commission to maintain separation of production from the two pay mones.
