Well was shut in during September 1966 when the water-oil ratio increased to a point that lifting costs exceeded revenue. Approximately 750 bbls water was pumped per bbl of oil, with a small volume of gas.

The well is now being held pending the possibility of remedial work to recomplete in the same zones as is now productive in the HMA Production Company Cities Service Federal #4.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
