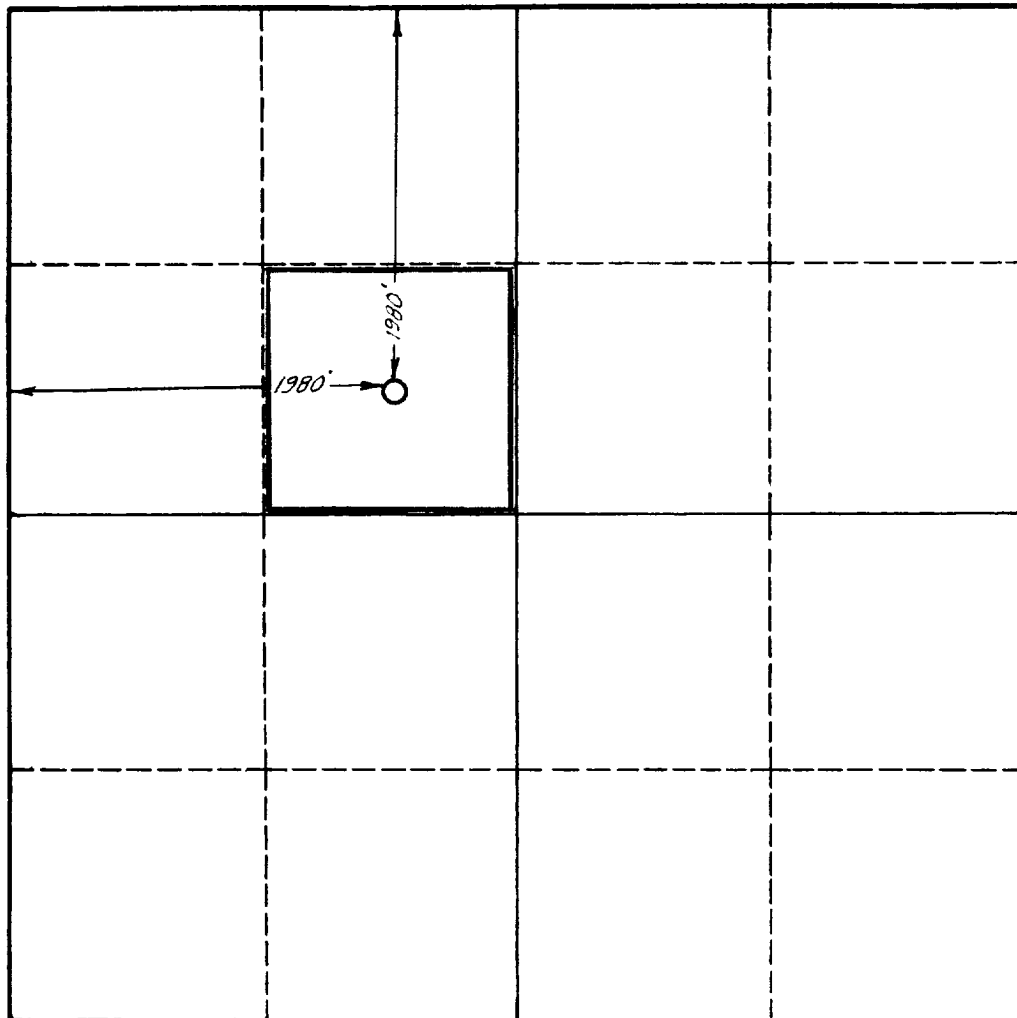

Started drilling on cement plugs @ 11:00 a.m. (MST), November 5, 1962. Found 13-3/8" casing near surface badly worn. Attempted to weld patch 6' below G.L. Tested casing to 200 psi and blew hole in casing. Removed BOP. Cemented 94' of 8-5/8" (24#, H-40) casing at 105' with 100 sacks Class A plus 2% CaCl<sub>2</sub>. Circulated approximately 25 sacks. Plug down @ 7:45 p.m. (MST), November 5, 1962.
