In October, 1974, the U.S.G.S. approved temporary abandonment of this well until November 1, 1975. The well was temporarily abandoned at an unknown date by the former operator as uneconomical to operate prior to unitization into the Myers Langlie-Mattix Unit 2-1-74. Present plans are to place the well in an active operating status in the second or third quarter of 1976. Skelly Oil Company respectfully requests that a one year extension to temporarily abandon this well be granted administratively as per New Mexico Oil Conservation Commission Order No. R-5019. Water injection is presently being expanded on this unit.

1) Move in workover unit.

2) Clean out to 3564' TD.

3) Check for casing leak, cement squeeze leak interval if necessary.

4) Drill new hole 3564-3610'.

5) Run GR-Neutron Log from 2900' to 3610'.

6) Set lined tubing and packer at ±3270'.

7) Load tubing-casing annulus with treated water.

8) Place well on active injection status, injecting water through the Langlie-Mattix open hole 3320-3610'.

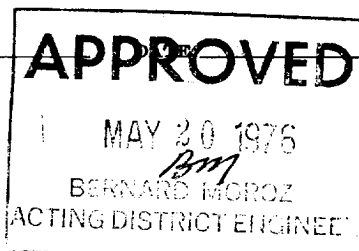
