DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On February 20, 1954 ran 8 jts (314') of 9-5/8" 36# J-55 casing. Set and cemented at 354' w/400 sacks regular neat cement. Plug at 324'. Pressure 250#. Circulated approximately 50 sacks. Job complete by HOWCO 7:45 PM 20th.

After waiting over 36 hours, tested 9-5/8" casing w/1000# for 30 minutes. There was no drop in pressure. Drilled cement plug from 334-354' and tested cement below casing shoe w/400# for 30 minutes. There was no drop in pressure.
