- 1) Move in workover rig. Pull rods and tubing.
- 2) Clean out to 3570' TD.
- 3) Run GR-N collar log 2800-3570'.
- 4) Perforate unitized interval as indicated by log.
- 5) Treat new perfs. with 750 gals. 15% NE acid.
- 6) Set coated injection tubing and packer approximately 50' above upper perforated interval.
- 7) Place well on injection status, injecting water through Langlie-Mattix perforated interval and open hole section 3410-3570'.
