Drilled to a total depth of 300', ran 281' of 8-5/8 " 24# casing set at 289' with 200 sacks of cement. Cement circulated to surface. Plug down at 11:30 AM 7-17-54. Cement set for 24 hours. Started drilling plug at 11:30 AM 7-18-54. After 10' of cement was drilled, applied 700# pressure and held for 30 minutes. No loss in pressure. Shut off okay.
