Finished drilling 12-1/4" hole @ 10:00 P.M., 4-5-55. Ran 8 Jts. of 8-5/8" OD 24# casing set @ 356' w/225 sacks cement. Pumped plug to 333' @ 1:00 A.M. 4-6-55. Max. pumping pressure, cement circulated. WOC 12 hrs. Tested 8-5/8" OD casing w/1000# before drilling cement. Held O.K. Drilled cement from 330' to 356'. Started drilling formation and 7-7/8" hole from 361' 4-6-55.
