Under provisions of Order R-553 delegating the Secretary of the Commission authority to grant an exception to the No Flare Order provisions of Order R-520, Pan American Petroleum Corporation hereby requests permission to flare casinghead gas from its C. Myers "B" Well No. 13, located in Unit "L", Section 9, T-24-S, R-37-E, Langlie Mattix Pool, Lea County, New Mexico.

In accordance with Commission Memorandum the following information is furnished:

 - (e) Additional information - Gas from Well No. 5 is presently being sold to El Paso through their high pressure system, however it will be necessary for them to install approximately 1400' of line to connect Well No. 13 to their low pressure system.
