DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 94 joints 3785.45' of 9-5/8" OD 36# J-55 SS casing. Set and cemented at 3799' w/3390 sacks cement, 3290 sacks 4% Gel Trinity Regular and 100 sacks Neat on bottom. Maximum pressure 900#. Plug at 3755'. Gulf temperature survey in 12 hours found top cement at 1210' from rotary table.

After waiting over 30 hours tested 9-5/8" casing w/1000# pressure for 30 min. There was no drop in pressure. Drilled cement plug from 3755' to 3799'. Tested cement below casing shoe w/500# pressure for 30 minutes. There was no drop in pressure.

After approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to drill ahead.
