DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Ran 10 joints 301' of 13-3/8" OD 8 RT 48# H-40 SS Casing. Set and cemented at 314' w/315 sacks Regular Neat Longhorn cement. Plug at 300' Maximum pressure 400#. Checked top cement in 5 hours, top at 25' behind 13-3/8" casing. Recemented thru 2" line pipe w/35 sacks Regular Neat El Toro cement. Circulated 5 sacks cement.

After waiting over 24 hours tested 13-3/8" casing w/1000# pressure for 30 minutes. There was no drop in pressure. Drilled cement plug from 300' to 314', tested cement below casing shoe w/400# pressure for 30 minutes. There was no drop in pressure.

After approval of Mr. Yarbrough, State Oil and Gas Inspector, preparations were made to drill ahead.
