MISU 8-1-84. Pulled rods and pump. Pulled tubing. Ran retrievable bridge plug and set at 6200'. Pressure tested to 1000 PSI and tested OK. POOH with retrievable bridge plug and tubing. Ran packer and set at 9771'. Fraced with 1500 gals 15% NE HCL with additives 9811'-9821'. Flushed with 56 bbls 2% KCL. Release packer and ran seating nipple, tubing and tubing anchor. Seating nipple landed at 9779' and tubing anchor set at 9746'. Installed pumping equipment and tested tubing to 500 PSI and tested OK. MOSU 8-6-84 and began pump testing. Pump tested apx. 7 days. Last 24 hours pumped 24 BO, 152 BW and 1 MCF. Well returned to production.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
