A foresight was set at the brass cap marker common to sections 9, 10, 15 and 16; the survey was started from the brass cap quarter corner marker common to sections 15 and 16 at station 0+00, thence south 660.0 feet, thence east 660.0 feet to the location at station 13+20.0, then to check we turned to the point of beginning and chained 933.1 feet which left an error of closure of 0.2 feet which is allowed in a survey of this nature.
