Humble Oil & Refining Company is owner and operator of an oil and gas lease located in the E/2 of SW/4 of Section 16, T-24-S, R-37-E, Lee County, New Mexico. Continental Oil Company is owner and operator of an oil and gas lease located in SW/4 of SW/4 of Section 16, T-24-S, R-37-E, Lee County, New Mexico. The Gulf, Humble and Continental leases comprise the 250 acres above described.
  - (2) Gulf Oil Corporation proposes that the above described acreage be established as a non-standard 250-acre gas proration unit in exception to Rule 5(a) of Order R-520.
  - (3) Gulf Oil Corporation is owner and operator of the J. R. Holt "A" Well No. 2 located 1980 feet from the west line and 660 feet from the south line of Section 16, T-24-S, R-37-E, Lee County, New Mexico, which was completed October 2, 1955, as a gas-oil dual well. This well is in the Jalmat Gas Pool and Langlie-Mattix Oil Pool. The applicant proposes to use this well as the unit well.
