## FULL DETAILS OF PROPOSED PLAN OF WORK (FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Intended Procedure: It is proposed to recomplete the well according to the fellowing procedure: ) Rig up, kill well with water and pull 2-inch tubing, 2) drop ball and damp 15 feet of coment on top of production packer, 3) perforate from 10,550 to 10,585 feet with 4 jets per foot, 4) set Baker Model "B" packer at 10,525 feet on wire line, 5) run 2-inch tubing, swab well in and test, 6) treat well with 500 gallons of mud acid, 7) swab out acid load and test, 8) tear down and place well on production.
