In Accordance with Form C-102 dated 1-20-64 this well was plugged and abandoned as follows:

1. Spotted 50 sx cement plug across perforations at 2510'.
2. Cut and pulled 5-1/2" casing from 1695'.
3. Spotted 25 sx cement plug in and out of 5-1/2" stub.
4. Pulled 8-5/8" casing from 240'.
5. Spotted 25 sx cement plug in and out of 8-5/8" stub and 25 sx in and out of 13" at 155'.
6. Spotted 10 sx cement plug at surface and erect FIA marker.
7. Restored ground to its natural contour and made final cleanup of location.
