## FULL DETAILS OF PROPOSED PLAN OF WORK (FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Well Productivity has declined below its economical limit. Repair possibilities do not exist. We propose to plug and abandon as follows:

1. Spot 50 sx cement plug across perforations at 2515'.
2. Cut and pull 9-5/8" casing from approx. 775'.
3. Spot 10 sx cement plug in and out of 9-5/8" stub.
4. Spot 10 sx cement plug at surface and erect FXA Marker.
5. Restore ground to its natural contour and make final cleanup of location.
