Noble Bros. Drilling Company spudded 13-3/4" hole at 9:45 AM on 11-8-63. On 11-8-63, 10-3/4" OD 32.75-51# H-40 & J-55 casing was run and set at 345' and cemented with 250 sz. cement circulated. After WOC 18 hours, tested casing with 600 PSI for 30 minutes. Test OK. Reduced hole to 9-7/8" at 345' and resumed drilling operations.


