Set packer at 7100' x test CIBP down tubing to 1000 psi x held. RU Halliburton x perforate through tubing from 7118' - 7160', 2 JSPF. Swab well. Acidize perms with 3000 gal. 15% HCL. Resume swabbing. Put well on plunger lift and turn well over to production. RD x MO.
