Fraced down tubing with 11000 gals 30# cross-linked 2% KCL and 26000# 20/40 sand. RIH with retrievable bridge plug and set at 5465, packer set at 5075'. Fraced down tubing with 17000 gals 30# cross-linked 2% KCL and 35500# 20/40 sand. Well screened out while pumping 5 lbs/gal with 15,750 51b stage. Clean-out to 5465' and RIH with seating nipple and set at 5658'. MOSU 8-6-84. Pump tested apx. 10 days. Last 24 hours pumped 52 BO, 100BW and 276 MCF. Well returned to production.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
