FEBRUARY 8, 2001

WELL DEAD, SWAB, FL AT 3000'. MADE 15 RUNS, RECOVER 75 BW AND 30 BO. LAST FL AT 2200' FROM SURFACE. WE ARE 937 BWUL AND 79 BOOL.

FEBRUARY 9, 2001

400 ON TBG AND 200 PSI ON CASING. FLOWED 2 HRS ON A 24/64" CHOKE, RECOVER 12 BO. SWAB, FL AT 2400'. MADE 6 RUNS AND WELL FLOWED THE REST OF THE DAY. AS OF 7:00 PM WE HAD RECOVERED 138 BW AND 65 BO. WE ARE 799 BWUL AND 144 BOOL. LEFT WELL FLOWING TO TANK ON A 24/64" CHOKE. TUBING HAD 300 PSI AND CASING HAD 400 PSI. WELL TESTER MONITORED THE WELL OVER NIGHT

FEBRUARY 10, 2001

WELL DIED THIS MORNING AT 8:00 AM. OVERNIGHT IT MADE 85 BO AND 60 BW. SHUT WELL IN UNTIL MONDAY. WE ARE 739 BWUL AND 229 BOOL.

FEBRUARY 11, 2001

SHUT DOWN FOR SUNDAY.

FEBRUARY 12, 2001

950# ON CASING AND 880 PSI ON THE TUBING. OPEN ON A 28/64" CHOKE. AFTER 2 HOURS WE SWITCHED WELL TO TANK BATTERY. IN 4 HOURS TO BATTERY IT MADE 22 BO, 6 BW, AND 26 MCF. LEFT WELL TO BATTERY ON A 32/64" CHOKE, CASING HAD 850 PSI AND TUBING PRESSURE WAS 60 PSI. TOTAL RECOVER TODAY IS 37 BO AND 12 BW. WE ARE 727 BWUL AND 266 BOOL. SHUT DOWN.

FEBRUARY 13, 2001

THIS IS A 24 HOUR TEST TAKEN THIS MORNING AT 8:00 AM TEXAS TIME. THIS INCLUDES PRODUCTION FROM YESTERDAY: 196 BO, 83 BW, AND 522 MCF. WELL FLOWING ON A 32/64" CHOKE, 225 PSI ON THE TUBING, 525 PSI ON THE CASING. OVERNIGHT THE WELL MADE 159 BO, AND 71 BW. WE ARE 656 BWUL AND 425 BOOL.

FEBRUARY 14, 2001

24 HR TEST, WELL MADE 162 BO, 41 BW, AND 748 MCF ON A 30/64" CHOKE, 230 PSI ON THE TUBING AND 475 PSI ON THE CASING. WE WILL LEAVE THE WELL FLOWING WITH THE BOP ON.....WE WILL LET IT FLOW TO BATTERY. RIG DOWN PULLING UNIT. WE ARE 615 BWUL AND 587 BOOL.

FEBRUARY 15, 2001

24 HR TEST, WELL MADE 95 BO, 4 BW, AND 724 MCF ON A 32/64" CHOKE, 180 PSI ON THE TUBING AND 460 PSI ON THE CASING. WE ARE 611 BWUL AND 682 BOOL.

FEBRUARY 16, 2001

24 HR TEST, WELL MADE 144 BO, 1 BW, AND 686 MCF ON A 32/64" CHOKE, 220 PSI ON THE TUBING AND 450 PSI ON THE CASING. WE ARE 610 BWUL AND 826 BOOL.

FEBRUARY 17, 2001

24 HR TEST, WELL MADE 128 BO, 2 BW, AND 635 MCF ON A 32/64" CHOKE, 218 PSI ON THE TUBING AND 450 PSI ON THE CASING. WE ARE 608 BWUL AND 954 BOOL.

FEBRUARY 18, 2001

24 HR TEST, WELL MADE 48 BO, 5 BW, AND 644 MCF ON A 32/64" CHOKE, 150 PSI ON THE TUBING AND 390 PSI ON THE CASING. WE ARE 603 BWUL AND 1002 BOOL.

FEBRUARY 19, 2001

24 HR TEST, WELL MADE 38 BO, 4 BW, AND 643 MCF ON A 32/64" CHOKE, 140 PSI ON THE TUBING AND 400 PSI ON THE CASING. WE ARE 599 BWUL AND 1040 BOOL.

24 HR TEST, WELL MADE 6 BO, 2 BW, AND 642 MCF ON A 32/64" CHOKE, 150 PSI ON THE TUBING AND 410 PSI ON THE CASING. WE ARE 597 BWUL AND 1046 BOOL.

WE HAD MESSED WITH CHOKE THE DAY BEFORE. PUT CHOKE BACK ON 32/64". 24 HR TEST, WELL MADE 81 BO, 5 BW, AND 643 MCF ON A 32/64" CHOKE, 190 PSI ON THE TUBING AND 410 PSI ON THE CASING. WE ARE 592 BWUL AND 1127 BOOL.

24 HR TEST, WELL MADE 84 BO, 6 BW, AND 623 MCF ON A 32/64" CHOKE, 185 PSI ON THE TUBING AND 420 PSI ON THE CASING. WE ARE 586 BWUL AND 1211 BOOL.
